GPI SA is managed by a board of directors comprised of Jean-Pierre Berghmans, Elisabeth van der Vaeren, Pascal Rakovsky and Rene Beltjens (acting through its management company Paradoes Ter Sarl), each of whom disclaims beneficial ownership of the Common Stock beneficially owned by FGI.
